### Getting Married at a Beachcomber Hotel with Chaka Travel

It is essential that you read the following information carefully as it outlines important information regarding the documentation required for your wedding in Mauritius.

Please ensure that you send all documents to us by scanned email no later than 10 weeks prior to travel and that they are both clear and complete (i.e. the photocopy of the passport photo is clear) as failure to do so could result in your wedding arrangements being delayed.

Beachcomber requires photocopies only and you must ensure that you travel with the **originals** of all documents.

Below is a list of documents we require 10 weeks prior to your departure:-

- ∞ Passport, (which expires more than 6 months after the date of your return to the UK)
- ∞ Birth Certificate, both long and short certificates are acceptable
- ∞ Decree Absolute, if you have been divorced
- ∞ Your former Marriage Certificate and original Death Certificate of your former spouse if you have been widowed
- ∞ Change of Name Deed Poll document if you have changed your name  
If you have been divorced and have reverted to using your maiden name then this counts as a name change and proof will be required
- ∞ Adoption papers, if you have been adopted
- ∞ Beachcomber's Mauritius Application to Marry form for Non-Citizens should be completed (Form enclosed)
- ∞ Any documentation not in English will need to be officially translated

All document information required above is based on marriages between British nationals only. If either of you is not a British national, it is your responsibility to

contact your embassy in case additional or different documents are required in addition to what we ask of. In some cases it may be necessary to send documents to Mauritius at least 3 to 6 months prior to arrival so we recommend you do this as soon as you have booked. **Original copies** of all the relevant documents above must be taken with you to Mauritius.

### Divorcees or Widow/ers

Under Mauritian law, weddings can only normally take place 300 days after a divorce decree absolute has been issued or after a death certificate of a previous spouse has been issued. If a wedding is required within this 300 day period a medical certificate confirming that the divorced woman or widow is not pregnant will be required. The medical certificate must be issued in Mauritius for which there will be a fee payable locally. If you have been divorced or widowed in the past 300 days and are pregnant, please advise us immediately.

### Ceremony Details

Ceremonies are arranged on weekdays only (**Monday to Friday**) conducted by Civil Status Officers.

If you would like a large group (wedding) booking at any of the hotels featured, please contact us and we will be glad to approach the hotel on your behalf to see if this is possible.

To satisfy the requirements of Mauritian law, it will be necessary for you to visit the Civil Status Office, Attorney At Law and Supreme Court. You will be contacted the day after arrival and advised on which day your visit to Port Louis will be, usually 1-3 days prior to the wedding day. If a pregnancy test is required this will be coordinated at the same time.

You will be accompanied by a taxi driver who will pick you up from your hotel and take you to the relevant offices before returning you to your hotel. Please note that it is compulsory for men to wear long trousers during the visit to the Civil Status Office.
